Chairperson's Report

for the financial year ended 28 February 2009

The past year was indeed a flurry of activity for Engender. We built on and consolidated existing projects such as our KhoeSan Women's project, Take Back Power project and our Community and Backyard Gardens project.

The KhoeSan Women's Project has contributed to groundbreaking research regarding the contribution of women and indigenous knowledge to nonviolent ways of resolving conflict. This research has been documented in our Executive Director's Master thesis, which will be published in a forthcoming book. Our Take Back Power project continues to capacitate *inter alia* women in abusive relationships to reclaim their agency and power. And our Community and Backyard Gardens Project promotes synergy between planet earth and her inhabitants, which accords with our holistic approach to transformation in South Africa. In 2008 we also embarked on a new project, Body Politics, which incorporates a much needed focus on issues of intersexuality.

Through all these projects, Engender has extended its reach to impoverished communities in the Western and Northern Cape provinces, and at national and international meetings. More details of these and other projects is enunciated in our Executive Director's Report.

Our work is made possible through the financial contributions of the following funding agencies to which we would like to extend special thanks: Action for World Solidarity, Atlantic Philanthropies, Breadline Africa, Dougherty Foundation, Fidelity Fund, Foschini Foundation, Heinrich Böll Foundation, Hope Springs Institute, Pequenita and Vaughan Foundation. Report of the Executive Director

for the financial year ended 28 February 2009

This was Engender's 6th year of operation, marked by constant creativity, as well as continually improved operational systems and management, for sustained strategic interventions. Since the personal is political, and vice versa, it was also the first anniversary of my giving up smoking, after 24 years of addiction, and the continuation of our engagement with ideas on the politics and practice of holistic women's wellness.

TRAININGS: KHOESAN WOMEN'S LEADERSHIP PROJECT

Project title: "Reclaiming Indigenous Women's Power in Southern Africa: the KhoeSan"

This was our key project through 2009. This project aims, in close consultation with local KhoeSan communities, to effect strategic interventions that are two-fold:

- (1) To develop female participation and leadership through capacity building and empowerment which is built on indigenous knowledge systems reflecting values of participation, gender equity, respect, nonviolence and consensus building.
- (2) To provide groundbreaking documentation of the contribution of women to the collective narrative history of the KhoeSan and to produce accessible publications. This can be used by especially community members and policy makers to effect meaningful policy and structural changes.

More information on Engender's website. Partnerships established with various local organisations, especially in the Northern Cape, and appropriate gender trainings provided, especially in collaboration with the South African San Institute. Funding introduced between local community leaders in the Kalahari and a Dutch donor, who now supports a women-owned caterer and restaurant in Askham. Various other collaborations are ongoing.

TRAININGS: TAKE BACK POWER PROJECT

Project title: "STRATEGIC INTERVENTIONS: Violence Stops with Me – Take Back Power and Agency to Stop Violence against Women and Others"

Based on actual needs within communities, this workshop series continues to grow and requests for workshops in different rural and urban communities far outstrip our capacity to implement. We again conducted workshops in Atlantis, the Kalahari, Upington and Platfontein (outside Kimberley), as well as in economically marginalised communities in Cape Town.

COMMUNITY & BACKYARD GARDENS project: Various individuals and groups have supported our project, including Biowatch and the Provincial Department of Agriculture. Local coordinators were appointed in two key communities: Village Heights and Atlantis.

BODY POLITICS project is focused on, by and for intersex people, and is supported by Atlantic Philanthropies. Lisa Middleton, previously national coordinator of

Canadian Youth for Choice, was project coordinator for this period. Lisa was actively supported by community activist, Funeka Soldaat, and Sally Gross during this time, as well as a German intern, Miriam van Damme. A vibrant website has been created, populated with publications (many by Sally Gross) and links to other publications, organisations and useful websites. Extensive workshops and trainings were conducted with a wide range of service providers, as well as other support services supplied, including individual and organisational support, as well as media liaison.

RESEARCH: Engender's Director, Bernedette Muthien, was awarded the Andrew W Mellon Research Fellowship at Stellenbosch University, for her research on the *KhoeSan and Partnership: Beyond Patriarchal Violences*. The thesis is being published in a forthcoming book by an international publisher. The thesis is widely hailed by local descendants of the KhoeSan and others, as well as internationally, for being thorough and pathbreaking – the first of its kind.

COLLABORATIONS & PARTNERSHIPS

Funding: Our work, and collaborations with various partners, would not be possible without the generous support of Action for World Solidarity, Atlantic Philanthropies, Breadline Africa, Dougherty Foundation, Fidelity Fund, Foschini Foundation, Heinrich Boell Foundation, Hope Springs Institute, Pequenita, and Vaughan Foundation. Various individuals in North America and Europe made generous donations to our work, and in South Africa and elsewhere many individuals donated time and other resources to Engender's projects.

Building Women's Activism, Building Women's Leadership, the Feminist Political Education Network: Engender partners with at least 12 other gender NGOs in the Western Cape and nationally, to help build grassroots women's activism and leadership, and to share training and political education resources. Partners include International Labour Research & Information Group (ILRIG), Sex Workers Education Advocacy Trust (SWEAT), New Women's Movement, AIDS Response, Treatment Action Campaign, Alternative Information and Development Centre (AIDC), Congress of South African Trade Unions (COSATU), Otherwise Media, Workers World Media Productions.

KhoeSan Women's Circle: Engender co-created this critical indigenous women's net-

work during 2007, and core members include Priscilla de Wet, Juliana Davids (Sonke Gender Justice), Yvette Abrahams (Commission for Gender Equality), Jean Burgess (Eastern Cape community leader), Dawn Bosman and others. This Cape-Town based network meets at least monthly and continues capacity building and other strategic support services (including research) for women and allies. Members have also been studying Nama (a KhoeSan language) with Pedro Dausab. Among others, members performed during the opening ceremony for the Association for Women in Development (AWID) international conference in Cape Town during November, as well as for Robben Island Museum's celebration of the 350th anniversary of Autshumatso, the historic KhoeKhoe leader.

Women's Place: This project is a close collaboration between Parliament and civil society, focused on engendering space for women in society, physical and virtual. Nadine Moodie, graduate student at Stellenbosch University, served as intern on this project. The project was launched on 27 November 2008 at Parliament. Engender acted as Secretariat for the project and the launch.

Cape Cultural Collective: Bernedette is a core member of this performing arts collective, with its roots in the anti-Apartheid struggles during the 1980s, and which performed at least monthly at the District Six Museum and in other community spaces.

International Feminists for a Gift Economy: Bernedette is member and attended their annual meeting at Villa Pace, near Ronciglione, Italy, 9-13 July 2008.

Digital Universe – Human Rights Portal: Engender continues to serve on the International Advisory Board of this electronic human rights search engine, database and reference, akin to Wikipedia.

070707 Campaign to End Hate: Engender is member of this provincial and national network of organisations focused on combating hate crimes against sexual minorities and women specifically.

Joint Working Group: Engender is member of this national network of sexualities and sexualities organisations.

AMREF South Africa: Engender conducted specially designed capacity building trainings on Children's Rights and Advocacy, to AMREF's national coordinators, 8-10 September 2008.



REPORT OF THE INDEPENDENT ACCOUNTING OFFICERS TO THE BOARD OF CONTROL

We have examined the Annual Financial Statements set out on pages 5 to 7 for the year ended 28 February 2009. These Financial Statements are the responsibility of the Board of Control. Our responsibility is to express an opinion on these Financial Statements based on our examination.

We conducted our examination in accordance with generally accepted accounting standards. Those standards require that we plan and perform the examination to obtain reasonable assurance that the Financial Statements are free of material misstatement. An examination includes:

- * the financial statements of the organisation are consistent with its accounting records;
- * the accounting policies of the organisation are appropriate and have been appropriately applied in the preparation of the financial statements; and
- * the organisation has complied with the provisions of the Non-Profit Organisations Act 71 of 1997 and its constitution, which relate to financial matters.

In common with similar organisations, it is not feasible for the organisation to institute accounting controls over income from donation and sundry fundraising activities prior to the initial entry of such income in the accounting records. Accordingly, it was impractical for us to extend our examination beyond the receipts actually recorded.

Subject to the above, in our opinion, the Financial Statements fairly represent the results of the operations of the organisation for the year ended 28 February 2009 and the financial position of the organisation at that date in accordance with generally accepted accounting practices.

In accordance with South African Statements of Generally Accepted Accounting Practice, the organisation recognises funding income from specific funders in the year that it relates to costs incurred.
